Introduction

These are the terms of licence that apply to this software (and any update/upgrade to it) and those electronic downloads (such as white papers and other digital content publications made available through such software) that we make available as part of a pre-installed software package with one of our products and/or for download from our website www.refeyn.com (**Site**) (or a combination of both) (respectively, the **Software** and **Downloads**).

These terms also apply to any of the services accessible through the Software, unless separate or additional terms apply, in which case they will be displayed on-screen or accessible via a link. Use of your personal information submitted to or via the Software is governed by our [Privacy Policy](#).

The Software and/or any Download is provided by or on behalf of Refeyn Limited (**we, us and our**). We are a limited company, registered in England. Our registered company number is 11333643, and our registered office is at 9400 C/O Penningtons Manches Llp, 9400 Garsington Road, Oxford Business Park, Oxford, England, OX4 2HN.

BY DOWNLOADING, ACCESSING AND/OR USING THE SOFTWARE AND/OR ANY DOWNLOAD, YOU CONFIRM THAT YOU ACCEPT AND AGREE TO BE BOUND BY THESE TERMS AND ACKNOWLEDGE THAT THEY CONSTITUTE A LEGALLY BINDING CONTRACT BETWEEN US AND YOU (AND, IF RELEVANT, ANY ORGANISATION ON WHOSE BEHALF YOU ARE ACTING). IF YOU ARE ACTING ON BEHALF OF ANY ORGANISATION, YOU CONFIRM THAT YOU HAVE THE REQUISITE AUTHORITY, POWER AND RIGHT TO FULLY BIND THAT ORGANISATION.
